



## **Magnum + UCAIR E-Bike Incentive Program: Official Rules and Eligibility Requirements**

- To be considered for this program, Utah residents must apply through the application on the [program homepage](#), located on the UCAIR website.
- Each application will be reviewed for eligibility, and all submitted documentation is subject to audit.
- Vouchers are available, one per person, to Utah residents over the age of 18.
- Voucher codes cannot be retroactively applied to past purchases. Voucher codes are valid for one-time use and only apply to new select Magnum e-bikes purchased on or after June 23, 2023.
- E-bikes purchased through this program must be for personal use by the applicant and not for resale. All e-bike purchases made using a voucher code from this program are final and non-refundable.
- Voucher codes are non-transferable, and employees at Magnum Bikes must confirm that the name on each application and voucher matches the name of each e-bike buyer at the time of pick-up and/or in-person sale.
- Each Utah resident can redeem only one Magnum e-bike voucher throughout the duration of the program. Once you have redeemed a voucher code for the purchase of a Magnum e-bike, you will be ineligible to apply for or receive another voucher in future rounds of this program.
- Different Magnum e-bike models will be included in the different e-bike categories: Commuter, Cruiser, and Cargo. Limited quantities of each model will be made available on a first-come, first-served basis. If the model you want is not available, more may be made available in future rounds of the program.
- Voucher codes will expire on the date specified in the original email containing your voucher code. This date will be no sooner than 60 days after this email is sent.
- Voucher codes must be redeemed before their expiration date.
- If your voucher code expires before you have the chance to make a purchase, you may re-apply to receive a new voucher code during future program cycles.

- The voucher code will be applied by Magnum Bikes to the full purchase price of a new eligible Magnum e-bike. Please note that no other discounts or voucher codes can be redeemed in conjunction with this program and its unique voucher codes.
- Vouchers may be redeemed only at the time of purchase for a new, eligible Magnum e-bike. Purchases must be completed either on the [Magnum Bikes website](#) or in person at a Magnum Bikes flagship store.
- Shipping will not be available for Magnum e-bikes purchased through this program.
  - If you purchased your e-bike online, the Magnum Bikes team will contact you after your order is processed to schedule an appointment for you to pick up your e-bike at a Magnum Bikes flagship store or an authorized retailer.

### **Document Guidelines**

- Please ensure to block out or redact any non-relevant, sensitive information such as account numbers, financial transactions, or Social Security Numbers included on documents.
- To be eligible for a Magnum e-bike voucher, you must be a Utah resident and 18 years of age or older.
- Proof of a physical Utah address is required. All documents must be dated within one year of application and must clearly show your name and address.
- To expedite the income verification process, please ensure that documents clearly show your name, income (annual or hourly), and household size.

### **Accepted Documents:**

- **Proof of Physical Address in Utah**
  - Examples of accepted documents include:
    - Unexpired Utah Driver's License
    - Unexpired Identification Card issued by the state of Utah
    - Computer Generated Bills (utility, credit card, doctor, hospital, etc.)
    - Bank Statement
    - Pre-Printed Pay Stub
    - First-Class Mail (from a government agency or court)
    - Current Homeowner's, Renter's, or Motor Vehicle Insurance Policy
    - Mortgage, Lease, or Rental Contract
    - Transcript from an Accredited School
    - Motor Vehicle Registration
    - DD-214
    - Individuals who are unable to provide any of the above documents to verify their physical Utah address may be eligible to provide alternative documents to meet the requirements.

- **Proof of Income**

- To be eligible for an income-qualified voucher, your household income needs to be below 60% of the state of Utah’s median household income, or below 200% of the relevant federal poverty level.
- From the most recent census data (2021), 60% of Utah median household annual income rounded up to the nearest dollar is \$47,480 or \$22.87 for hourly pay.

  - Proof of enrollment such as a benefit approval letter in other programs with the same or lower poverty limit:
    - Utah Home Energy Assistance Target (HEAT) Program
    - Low Income Home Energy Assistance Program (LIHEAP)
    - Supplemental Nutrition Assistance Program (SNAP)
    - Children’s Health Insurance Program (CHIP)
    - Women, Infants, and Children (WIC)
    - Family Employment Program (FEP)
    - Medicaid
  - Pay Stubs
  - Proof of Supplemental Security Income (SSI)
  - Proof of Social Security Disability Insurance (SSDI)
  - Proof of Old Age Pension (OAP)
  - Cover page of previous year tax Form 1040
  - Your Form SSA-1099
  - A written statement from employer
